Emergency Financial Manager of the City of Ecorse (Directive No. 038)

ORDER OF THE EMERGENCY FINANCIAL MANAGER OF THE CITY OF ECORSE, COUNTY OF WAYNE, STATE OF MICHIGAN, APPOINTING THERESA CAPRA TO THE ECORSE BROWNFIELD REDEVELOPMENT AUTHORITY (EBRA).

WHEREAS, under the Local Government Fiscal Responsibility Act, Act 72, Public Acts of Michigan, 1990, as amended ("Act 72") and a Contract (the "Contract") between the State of Michigan and Joyce A. Parker, dated October 30, 2009, Joyce A. Parker has been appointed as the Emergency Financial Manager (the "EFM") of the City of Ecorse, County of Wayne, Michigan (the "City") and charged with the power to take actions with respect to the City, including the power to exercise the authority and responsibilities of the Mayor, as Chief Administrative Officer of the City, and of the City Council, as the governing body of the City, concerning the adoption, amendment and enforcement of ordinances or resolutions affecting the financial condition of the City as provided in the Home Rule City Act, Act 279, Public Acts of Michigan, 1909, as amended ("Act 279"); and

WHEREAS, pursuant to Act 72 and the Contract, the EFM, as the Chief Administrative Officer of the City, notwithstanding the provisions of any charter to the contrary, is authorized to consolidate departments of the unit of local government or transfer functions from 1 department to another and to appoint, supervise, and, at his or her discretion, remove heads departments other than elected officials, the clerk of the unit of the local government, and any ombudsman position in the unit of local government for the City as she may deem necessary within her sole discretion to accomplish the Purposes of Act 72; and

WHEREAS, pursuant to the City of Ecorse vs. Ecorse Brownfield Redevelopment Authority and Ecorse Community Development Corporation, Wayne County Case No. 08-104027, the Honorable Judge Michael F. Sapala ruled on May 20, 2010 that the Emergency Financial Manager has the power and authority pursuant to Public Act 72 to appoint members to the Authority's board of directors; and

WHEREAS, the EFM has determined it is the best financial interest of the City to appoint Theresa Capra to the EBRA.

NOW THEREFORE, BE IT ORDERED BY THE EMERGENCY FINANCIAL MANAGER OF THE CITY OF ECORSE, PURSUANT TO ACT 72 AND THE CONTRACT, THAT:

- 1. Theresa Capra is appointed a member of the EBRA.
- 2. <u>Repeal</u>. All orders of the EFM, resolutions of the City Council of the City, and parts of resolutions or orders in conflict with this Order are hereby repealed to the extent of such conflict.
