

ORDER OF THE EMERGENCY MANAGER OF THE CITY OF ECORSE

ORDER OF THE EMERGENCY MANAGER OF THE CITY OF ECORSE, COUNTY OF WAYNE, STATE OF MICHIGAN, AUTHORIZES IMPLEMENTATION OF CERTAIN ACTIONS IN THE FIRE AND PUBLIC SAFETY DEPARTMENT

(Order and Directive No. 077)

WHEREAS, under the Local Government and School District Fiscal Accountability Act, Act 4, Public Acts of Michigan, 2011, as amended ("Act 4") and a Contract (the "Contract") between the State of Michigan and Joyce A. Parker, dated October 30, 2009, Joyce A. Parker has been appointed as the Emergency Manager (the "EM") of the City of Ecorse, County of Wayne, Michigan (the "City") and charged with the power and authority to take all actions necessary to develop and implement financial and operational plans to regulate expenditures, investments and the provision of services for the City of Ecorse in conformity with and using the powers set forth in Act 4;

WHEREAS, this Directive and Order is necessary in order for the City of Ecorse to carry out the comprehensive duties and responsibilities required of the Emergency Manager as set forth in Public Act 4 of 2011, the contract between the Local Emergency Financial Assistance Loan Board and the Emergency Manager and, is considered necessary to implement the City of Ecorse's financial plan.

**THEREFORE, BE IT RESOLVED, IT IS HEREBY ORDERED BY THE EMERGENCY
MANAGER OF THE CITY OF ECORSE, PURSUANT TO PUBLIC ACT 4 of 2011, THE
CONTRACT, THAT:**


PURSUANT TO THE AFOREMENTIONED AUTHORITIES AND POWERS, THE FOLLOWING IS

HEREBY IMPLEMENTED AND EFFECTIVE IMMEDIATELY:

1. The Public Safety Director, with the approval of the Emergency Manager, may implement 12-hour Shifts. All schedules will be adjusted accordingly and all benefits will be modified to reflect the 12-hour shift. The 12-hour schedule and the adjusted benefits will be presented by the Public Safety Director to the Emergency Manager for her approval. The decision of the Emergency Manager on this issue shall be final.
2. The City of Ecorse shall contract with the City of River Rouge to provide Fire Marshal services. This will take effect immediately subject to entering into a satisfactory agreement with the City of River Rouge on this issue.
3. The policies and procedures presented by the Public Safety Director are effective immediately. Members of the Fire Service will be notified of these Policies and Procedures.
4. Repeal. All orders of the Emergency Manager, resolutions of the City Council of the City and parts of resolutions or orders in conflict with this Order are hereby repealed to the extent of such conflict. Additionally, all prior Implementations Orders and/or contracts or policy provisions to the contrary shall be superseded by this Order.

THIS IMPLEMENTATION ORDER IS EFFECTIVE IMMEDIATELY.
